

City Council Meeting Minutes

April 11, 2023

THE CITY COUNCIL OF THE CITY OF MUNDAY, TEXAS MET ON THIS DAY IN REGULAR SESSION IN THE CITY OF MUNDAY CONFERENCE ROOM AT 6:00 PM. Mayor Robert Bowen called the meeting to order at 6:00 PM. Development Corp A of Munday Update

The Development Corp of Munday met on April 4, 2023. There was no financial report but they are doing well. The board released the previous tenant of the old Chamber building and currently two individuals are trying to lease that space for an office. The individuals are Cindy Kessler and Clay Morrow (AMA Techtel). The Fire Department will also be looking for property to build Rodeo Grounds as the old grounds will be turned into a baseball field. The current year to date from the Comptroller is \$34,700.

Development Corp B of Munday Update

David Trevino is unsure of the date of the last meeting but it was around a year ago. The current year to date from the Comptroller is \$17,371 with \$175,000 in the bank. The B board helps with community projects. A company has donated a Ring Camera possibly two that can be placed at the park but Wi-Fi would be needed the board could possibly help with that.

Swimming Pool

Brittany Lowe won't know until May 1, 2023 if she will be able to run the pool or not due to things changing. The guys have dug up the valve and are waiting for repair while trying to get the pool ready. Plan B would possibly be the City hiring lifeguards.

Audit update

We are working to get everything they need and are waiting for the EDCB report. Hopefully they will be here next month.

All previous minutes, reports and financial statements were reviewed with no questions. Council Person Singleton made a motion to approve all previous minutes, reports and financial statements. Council Person Smith seconded. All present were in favor.

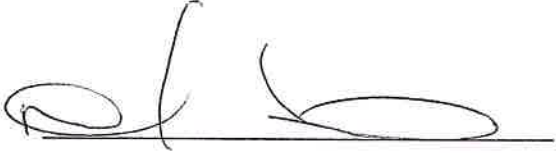
Personnel Matters
