

City Council Meeting Minutes

September 12, 2023

THE CITY COUNCIL OF THE CITY OF MUNDAY, TEXAS MET ON THIS DAY IN REGULAR SESSION IN THE CITY OF MUNDAY CONFERENCE ROOM AT 6:00 PM. Mayor Robert Bowen called the meeting to order at 6:00 PM. Council members present were Council Person Singleton, Council Person Smith and Council Person Torres.

There were no public comments at this time.

Open Public Hearing

Council Person Singleton made a motion to open the public hearing for the 2023-2024 Operating and Enterprise Budget. Council Person Smith seconded. All present were in favor.

Open Public Hearing on 2023 Tax Rate

Council Person Singleton made a motion to open the Public Hearing for the 2023-2024 Tax Rate and Council Person Smith seconded. All present were in favor.

DCOM Type A Candidate

Mayor Robert Bowen recommended Skye Urbanczyk for the Board. Council Person Smith recommended Cindy Kessler to the Board. Council Person Smith made a motion to appoint Cindy Kessler to the DCOM Type A Board, the motion failed due to the lack of second. Council Person Singleton made a motion to appoint Skye Urbanczyk to the DCOM Type A Board and Council Person Torres seconded. The vote was 2 for and 1 against.

Grants –Storm Pumps

This is the next TDA Grant. A pump failed from the last storm and costs around \$20,000 to rebuild or replace. This Grant will help with flooding downtown and if worse comes to worse money from the yard rehab can be moved to pay for a pump or hold off.

Close Public Hearing

Council Person Singleton made a motion to close the Public Hearing for the 2023-2024 Operating and Enterprise Budgets and Council Person Smith seconded. All present were in favor.

2023-2024 Operating Budget

Funds were added to the Park line item, \$1000 was added to the Judge's pay and the Chiefs raise was added in also. Council Person Smith made a motion to approve the 2023-2024 Operating Budget and Council Person Singleton seconded. All present were in favor.

2023-2024 Enterprise Budget

The Water Authority new rates came in and there is going to be a \$300 savings per month. Council Person Singleton made a motion to approve the 2023-2024 Enterprise Budget and Council Person Smith seconded. All present were in favor.

Close Public Hearing on the 2023-2024 Tax Rate

Council Person Singleton made a motion to close the Public Hearing for the 2023-2024 Tax Rate and Council Person Smith seconded. All present were in favor.

Tax Rate for 2023

The Tax Rate is suggested to be the same 1.13779000 rate from the previous year. Council Person Smith made a motion to approve the tax rate at 1.13779000 and Council Person Torres seconded. All present were in favor.

Ordinance Update

David didn't get a chance to get out and drive around so there is no update at this time.

All previous minutes, reports and financial statements were reviewed with no questions. Council Person Singleton made a motion to approve all previous minutes, reports and financial statements. Council Person Smith seconded. All present were in favor.
