Item 7: Heard, discussed city personnel – City Manager. Went into executive session at 7:38 P.M. Ended executive session at 8:46 P.M.

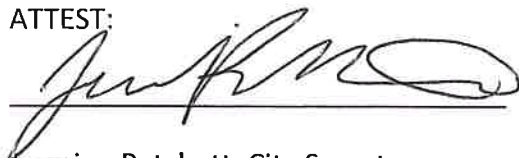
Item 8: Heard, Discussed and acted on the following-
