

City Council Meeting Minutes

April 9, 2024

THE CITY COUNCIL OF THE CITY OF MUNDAY, TEXAS MET ON THIS DAY IN REGULAR SESSION IN THE CITY OF MUNDAY CONFERENCE ROOM AT 6:00 PM. Mayor Robert Bowen called the meeting to order at 6:00 PM. Item 1: Hear, discuss, act on accepting or denying Trust Property Bid: Timothy Wertz of Munday, TX to bid for purchase of trust property located at Block 37, SE 100' x 100' of the Lee Addition. City of Munday, Knox County, Texas; R9224 Cause No 8684. His plans are to rehab and remodel this space in order to bring in a new business.
