B. City Judge Report- Councilwomen Joyce Sanders motioned to approve the Judge's report, seconded made by Exa Lee Smith.

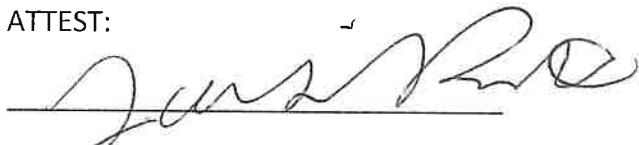
