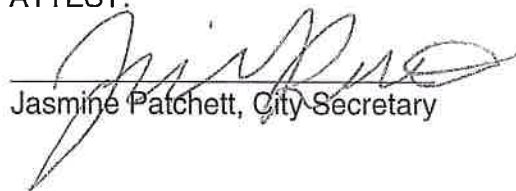
Councilmen Jayla Sanchez motion to approve all except Bills/Statement, and seconded by Councilmen Exalee Smith.
