

City Council Meeting Minutes

May 14, 2024

THE CITY COUNCIL OF THE CITY OF MUNDAY, TEXAS MET ON THIS DAY IN REGULAR SESSION IN THE CITY OF MUNDAY CONFERENCE ROOM AT 6:00 PM. Mayor Robert Bowen called the meeting to order at 6:00 PM. Council members present were Councilmen Singleton, Councilmen Smith, Councilmen Longan, and Council elect Skye Urbanczyk, Jayla Sanchez, and Joyce Sanders.

City Staff present: City Manager David Trevino, City Judge Laura Hample & Police Chief Dusty Bryant.

Visitors present: Chris Arnett, Wesley Clark, and Don Thompson, Maggie Booe

Invocation –Wesley Clark /Pledge- Dusty Bryant

Public Comments: Chris Arnett, spoke on the topics of posting City Council agendas properly. David Trevino thanked former pastor Wesley Clark and Cody Dykes on their contributions for the City of Munday.

Item 1: Hear, discuss, act on approving minutes from previous meeting. Mayor Bowen entertained a motion to except previous council minutes. Councilmen Singleton motion to accept minutes. Councilmen Smith second. All present voted for. Motion passed.

Item 2: Hear, discuss, act on canvassing City Council election. No questions or concerns. Election results excepted.

Item 3: Swore in new Council members. Municipal Judge Lara Hample swore in Jayla Sanchez, Joyce Sanders, Skye Urbanczyk, Karen Longan.

Item 4: Hear, discuss, act on disbursement of funds for the DCOM-A to pay \$36,900 to Daniel Abila for concrete work at the MEC. Maggie Booe and Richard Albus made a presentation. Mayor Bowen entertained motion. Motion made by Councilmen Longan. Councilmen Smith second. Councilmen Sanders and Sanchez votes for. Councilmen Urbanczyk abstained. Motion passes.

Item 5: Hear, discuss, acted on hear to discuss, act on approving disbursement of the DCOM-A to pay Booe Roofing \$22,050 for spray foam material for underlayment for the new roofing at the MEC. Maggie Booe and Richard Albus made presentation. Mayor Bowen entertained motion. Councilmen Longan motioned to approve funds. Councilmen Smith second. Councilmen Sanders votes for. Councilmen Urbanczyk and Sanchez abstained. Motion passes.

Item 6: Hear to discuss, act on adding Robert Bowmen (Mayor), Karen Longan (Mayor Pro-Tem), David Trevino (City Manager), Shanon Cross (City Secretary) To all signature card related to City of Munday bank accounts at First Bank Texas. Item was tabled due to new city secretary.

Item 7: Hear, discuss, and consider options on City of Munday's Certificate of Obligation. City Manager Trevino explained that the Certificate of Obligation will be paid off February 2025. City Manager Trevino put forth different options to consider. Will revisit in future council meeting.

Item 8: Hear, discuss, act on updating ordinance on door to door solicitation. Chief of Police Dusty Bryant made a presentation to make it harder to apply for vender permit. Council suggested time of siltation of 10am-5pm and double the fee and enough time to do a background check. Item then tabled to draw up new ordnance.

Item 9: Hear, discuss update with TCEQ. City Manager Trevino updated Council on previous violations. Main concern is the possibility to having to add more water storage for the city. City Manager Trevino is working with Engineering Firm Jacob and Martin to explain that the city does have extra water storage with N.C.T.M.W.A. Waiting to hear back from TCEQ on this matter.

Item 10: Heard, discuss update on Munday swimming pool. City Manager Trevino, Mayor Bowen, Morgan Verette met with Megan Harris from Community Foundation of Abilene in Abilene. City Manager Trevino informed Council of the different phases of restoring the pool and the park. CFA will notify applicants on Augusts 1st if grant was approved.

Item 11: Hear, discuss on Life Station rehab. City Manager Trevino updated Council on the rehab on the lift station and the delay of the project. Project to start beginning of June.

Item 12: hear, discuss city ordinances. Chief of Police Dusty Bryant updated council on maps for Sexual Offender Ordinances.

Item 13: Hear, discuss and act on the following monthly reports:

- A. **City Judge Report** – Judge Hample spoke on juveniles rights.
- B. **Munday Police Department**
- C. **Monthly Bills**
- D. **Review Monthly financial statements**
- E. **City Manager report-** City Manager Trevino asked newly elected Council members to go to TML website and watch video on Public information act and Open Meetings Act, bring certificate of completion to City Hall.

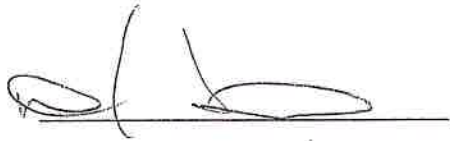
