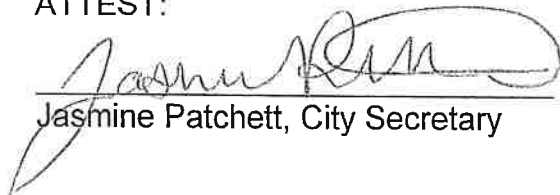

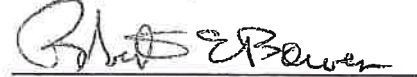
- F. City Managers Report- Mayor Robert Bowen motion to approve the City Mangers report, seconded by Councilwomen Exa Lee Smith.
