Item 3: Hear, discuss, and consider changes and updates to the 2024-2025 Operating Budget for the City of Munday.

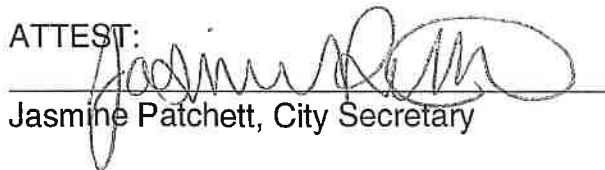
No Motion taken.
